# OUR IMPACT

In 2019, we served 2,042 clients, impacting the lives of 2,707 minors and providing over 1.8 million in free and low-cost legal services.



604 clients developed an understanding of their legal rights and responsibilities



170 parents improved a relationship with the other parent, their child, or both



90 parents were able to obtain or increase custody of their child



Staff attorneys and volunteers made 334 appearances on behalf of 157 clients



40 clients established a safety plan to reduce their risk of abuse



Successful adoptions resulted in 40 new families

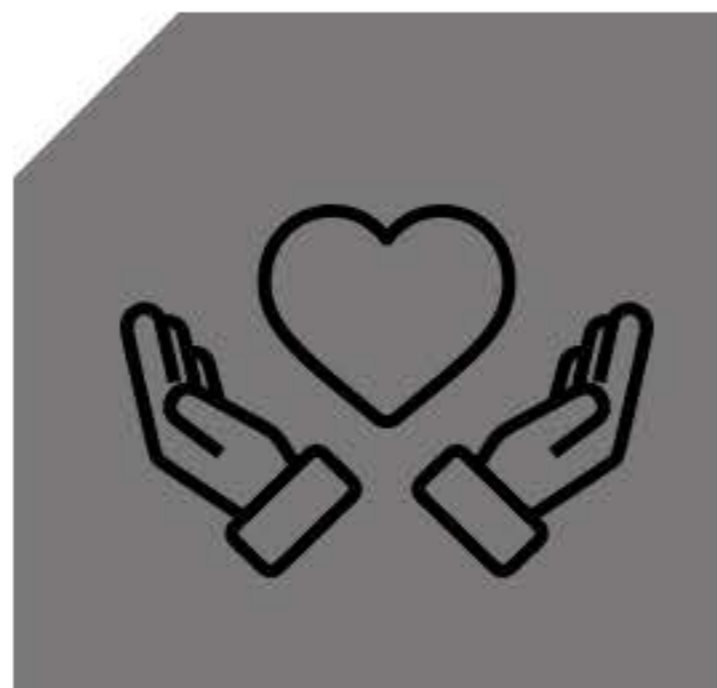
# OUR REACH

Our community engagement work is about increasing our presence and accessibility within our community while avoiding growth that dilutes services or leads to mission drift. We accomplish this through:



## Partners

We partner with other nonprofits who serve similar populations to hold community and videoconference-based clinics throughout LA County.



## Volunteers

Private attorneys, students from six area law schools and several community colleges help us provide much needed legal help.



## Technology

Purposeful technology integration allows us to connect with clients by video, eliminating barriers of time and distance to allow for greater efficiency and increased access to services.

Begun in 2017, our community engagement efforts continue to grow and adapt as we habitually reassess client needs, outputs, and outcomes.

20 clinics with 5 different partners

\$450,000 worth of time donated by over 48 volunteers

31% of our clients arrived at our doors due to a referral from a community organization

10% of our clients came to us via our clinic partners
