LevittQuinn is hiring a J.D. Post-Graduate Fellow to help support this work.

## Essential responsibilities of the Fellow may include:

- Prior to admission to the Bar, work under the supervision of LevittQuinn attorneys to provide direct services to clients
- Upon admission to the Bar, provide direct representation and advocacy
- · Interview and counsel clients with family law, adoption, and guardianship issues
- Participate in community education and outreach efforts
- Actively contribute to program development
- Other duties as assigned

## Qualifications:

- J.D. from an accredited law school or 3L with anticipated J.D.
- Registered or planning to sit for the California State Bar
- Strong commitment to LevittQuinn's mission
- Demonstrated ability to communicate effectively orally and in writing in English is essential, in Spanish is preferred
- Knowledge of family law issues, including child custody, domestic abuse, parentage, and support
- Although this is a position that starts **prior to receiving bar results**, obtaining active membership in the California State Bar may be required to maintain the position
- Demonstrated collaborative work style
- Commitment to professional growth and leadership development

**Compensation**: \$25/hour law clerk position prior to being admitted to the California State Bar. \$65,000 upon admission to the Bar. Generous benefits package and a hybrid work environment.

**Terms of the Fellowship:** Fellowship is for 1-year commencing September 3, 2024, renewable for a second year. Fellowship may be terminated early if not admitted to the Bar on the first attempt.

**Applications:** Applications will be accepted from 3Ls starting September 1, 2023.
