# Mission

---

LevittQuinn is a nonprofit family law center protecting children and standing with family members in crisis.

---

# Impact

---

LevittQuinn's staff of eleven helped **1,625 clients** and touched the lives of **2,221 children**.

We made **245 in-person and remote appearances** on behalf of **134 clients**, giving them **\$945,000** worth of low- to no-cost direct representation that secured court orders about the care of children, financial support, and protection from abuse.

**Forty-five volunteers** donated over **\$116,924** worth of their time working alongside staff in the office, at **19 remote legal clinics**, and at events. The clinics allowed us to **serve 100 people** throughout Los Angeles County and beyond.

**365** people developed an understanding of their rights and responsibilities



**226** clients received access to a fair court hearing



**54** parents were able to obtain or increase custody of their children



**\$156,561** in community property division and **\$125,940** in savings from moving to a more affordable place



Successful adoptions resulted in **45** new families, benefitting **99** minor children



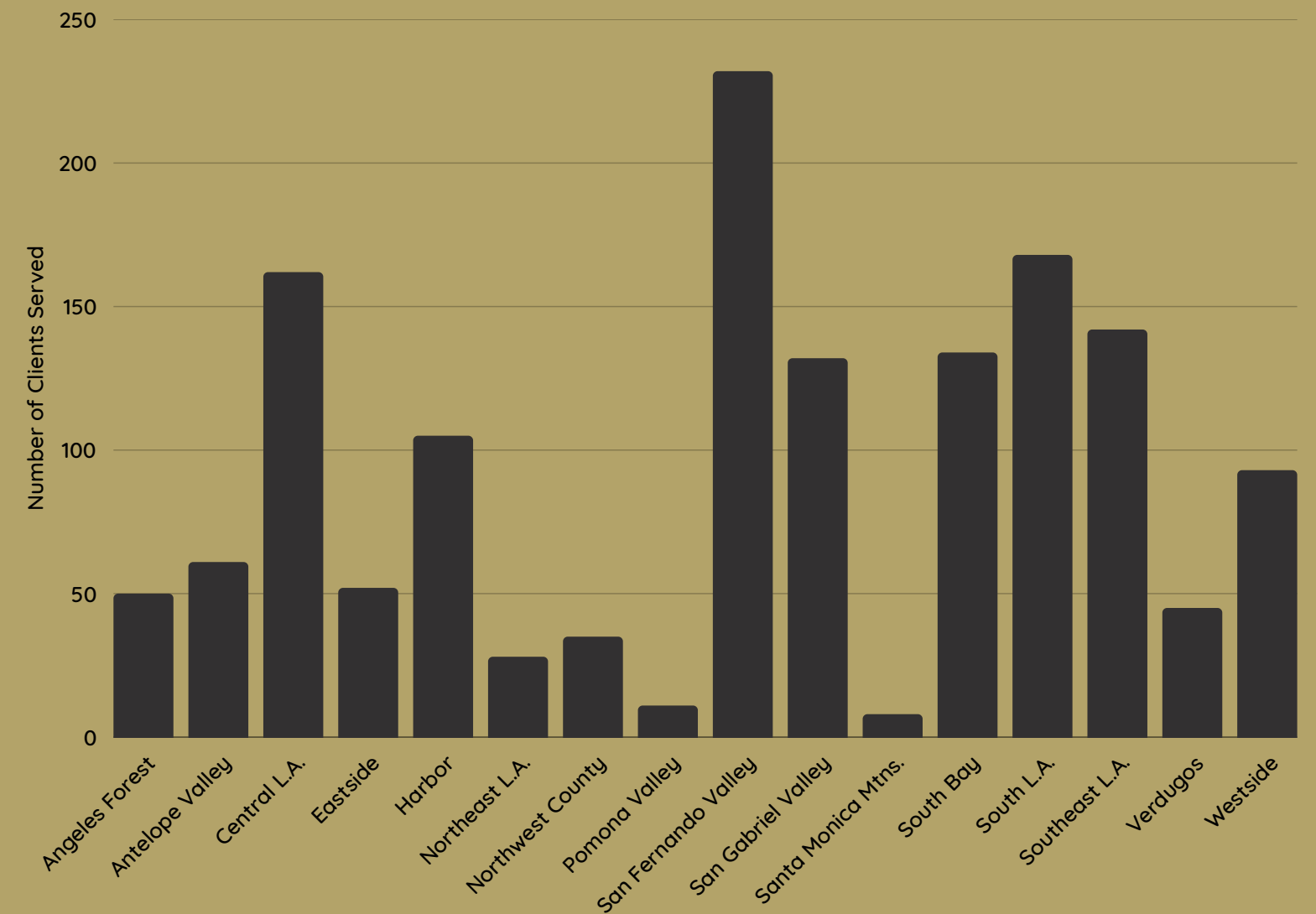
**65** parents improved a relationship with the other parent, their child(ren), or both

# COURT APPOINTMENTS



In addition to our programs, judges appoint LevittQuinn attorneys to represent adults and children in high-conflict adoption and family law cases.

In 2024, **25 families** benefitted from our court-appointed services, including **seven child clients**.

# Representation Matters

---

## Our legal services cover the full range of family law issues. In 2024:

- We stood in court with a 40-year-old father who is a Regional Center client, negotiating with the Child Support Services Department to get him a fair child support order.
- Our representation of a pair of Spanish-speaking grandparents resulted in the court finalizing their adoption of their 9-year-old grandchild, the child of their deceased daughter.
- We appeared in court and prepared a settlement agreement for a 55-year-old monolingual Spanish-speaking mother who was barely surviving on less than \$900 per month, securing interim orders for child and spousal support.
- We represented a 42-year-old father who has limited mobility and speech due to a stroke, helping him secure a fair child support order and negotiate for increased parenting time.
- Our representation helped a 45-year-old mother of two to secure an enforceable child support order in her parentage action.
- We negotiated a stipulated agreement for a 50-year-old mother of one that resolved her divorce, custody, and support issues.
